The EVO_EVOEVOEVOE_v1913 strategy on PLMR generated a marginal +0.43% return with a 50% win rate, yet the 14.67% maximum drawdown signals severe vulnerability to single-event volatility. A sample size of only two trades renders the Sharpe ratio of 0.14 statistically insignificant and provides no confidence in the strategy's robustness. The lack of diversification and low trade frequency suggest the parameters are overfit to noise rather than capturing a sustainable edge. You must expand the backtest horizon to validate stability before considering live deployment or parameter adjustments.
