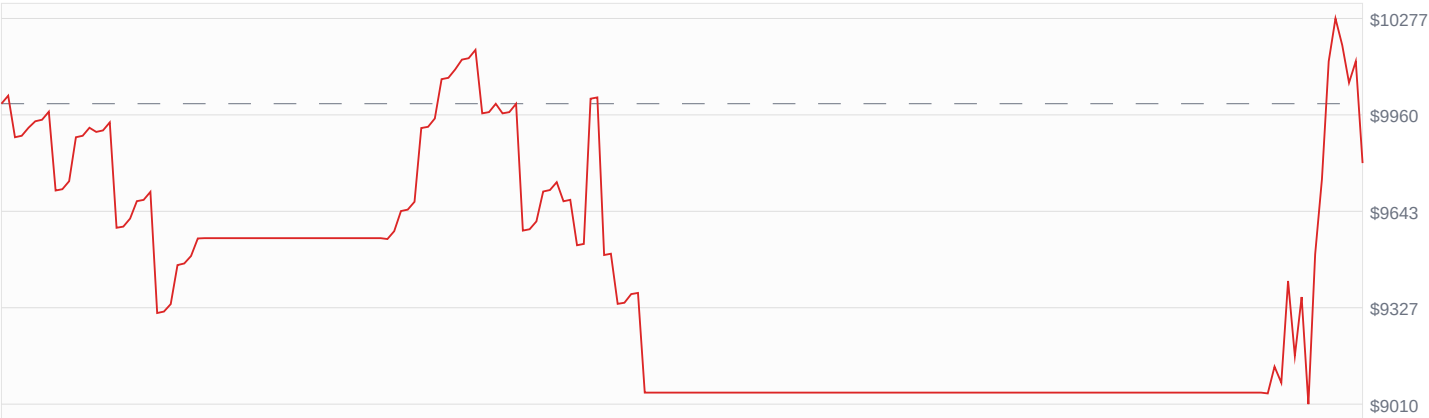

ANALYST NOTE

Hera local LLM

The VOXR backtest for EVO_EVOEVOE_v2327 generated a negative ROI of -2.01% and a -0.05 Sharpe ratio across only three trades, rendering any performance metrics statistically insignificant. The 33.3% win rate combined with an 11.32% maximum drawdown suggests the strategy failed to capture alpha while exposing significant downside risk on a micro-sample. Without sufficient trade frequency to validate signal consistency, the current output cannot support deployment or parameter optimization. We must re-run the simulation with a broader lookback window or adjust entry filters to generate a robust sample size before reconsidering the approach.
