Hera local LLM

The EVO_EVOEVOEVOE_v1793 backtest on AAPL shows a +10.70% return but lacks statistical significance due to only two trades. With a Sharpe ratio of 0.87 and a max drawdown of 11.50%, the strategy offers limited risk-adjusted evidence of robustness. The 50% win rate suggests a coin-flip edge rather than a consistent alpha generator. We must run a larger sample backtest to validate performance before live deployment.
