ANALYST NOTE

The VOXR backtest for EVO_EVOEVOE_v2171 reveals a failing strategy with a negative ROI of -2.01% and a Sharpe ratio of -0.05, indicating no risk-adjusted return. With only three trades executed, the 33.3% win rate and 11.32% maximum drawdown are statistically insignificant and likely noise rather than a coherent alpha signal. The sample size is far too small to validate any entry logic or confirm trend-following efficacy for this asset. We must increase the sample size through a longer simulation period or reduce volatility filters before deployment. Re-running the test with expanded historical data is the necessary next step to validate or discard the current approach.
