The EVO_EVOEVOEVOE_v2108 strategy on RDN failed catastrophically, losing 5.59% with a -0.31 Sharpe ratio and zero winning trades across a sample of only three transactions. This minimal dataset provides no statistical confidence for any generalizable conclusion, and the 14.78% maximum drawdown indicates severe vulnerability to specific market regimes. The strategy clearly lacks robustness, as it was unable to capture any alpha in this specific simulation. Next, we must re-evaluate the entry filters to ensure the logic generates sufficient trade frequency before risking live capital. This approach ensures we avoid deploying a strategy with inadequate historical validation.
