The VOXR backtest for EVO_EVOEVOEVOE_v2036 shows a -2.01% ROI with a negative Sharpe ratio of -0.05, indicating the strategy lost more on losses than it gained on wins. With only 3 total trades and a 33.3% win rate, the sample size is statistically insufficient to validate any edge or reliability. An 11.32% maximum drawdown suggests significant volatility exposure that the current risk parameters failed to manage effectively. We must expand the backtest window or adjust entry filters to generate a statistically significant sample before deployment. The next step is to run a sensitivity analysis on stop-loss placement to see if reducing exposure improves the risk-adjusted return profile.
