The backtest for RDN under the EVO_GG1RSISNIP_v229 strategy failed completely, showing zero winning trades and a negative Sharpe ratio of -0.31. With only three trades executed, the statistical sample is too small to draw any meaningful conclusions about the strategy's viability. The maximum drawdown of 14.78% indicates significant downside risk that was not mitigated by the current logic. Given these results, the strategy requires immediate re-optimization or abandonment before risking real capital. We must reject this configuration and seek alternative entry filters.
