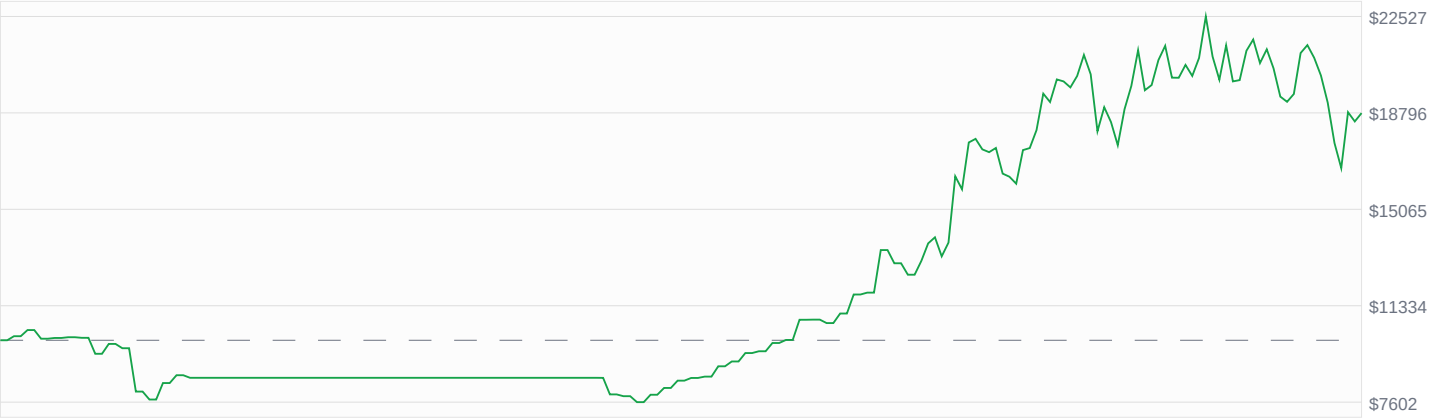

ANALYST NOTE

Hera local LLM

The EVO_EVOWEBIDEA_v180 strategy on AMD generated an impressive 87.88% return, but the 26.05% drawdown and only two trades reveal a severe overfitting risk. A Sharpe ratio of 1.61 appears robust yet lacks statistical confidence without sufficient trade volume to validate consistency. The 50% win rate suggests random noise rather than a reliable edge, as the strategy failed to capture the asset's volatility effectively. I recommend expanding the backtest window to 60 months or optimizing entry filters to generate at least 100 trades before live deployment.
