The EVO_EVOWEBIDEA_v406 strategy failed on VOXR, generating negative returns with a Sharpe ratio of -0.05 and a maximum drawdown exceeding 11%. Only 3 trades were executed, yielding a win rate of 33.3% and an ROI of -2.01%, which renders statistical inference impossible due to the vanishingly small sample size. The severe drawdown suggests a critical flaw in entry logic or an overreaction to a specific market regime during the test period. Immediate next steps involve expanding the backtest window to gather sufficient data points before attempting any live deployment or parameter optimization.
