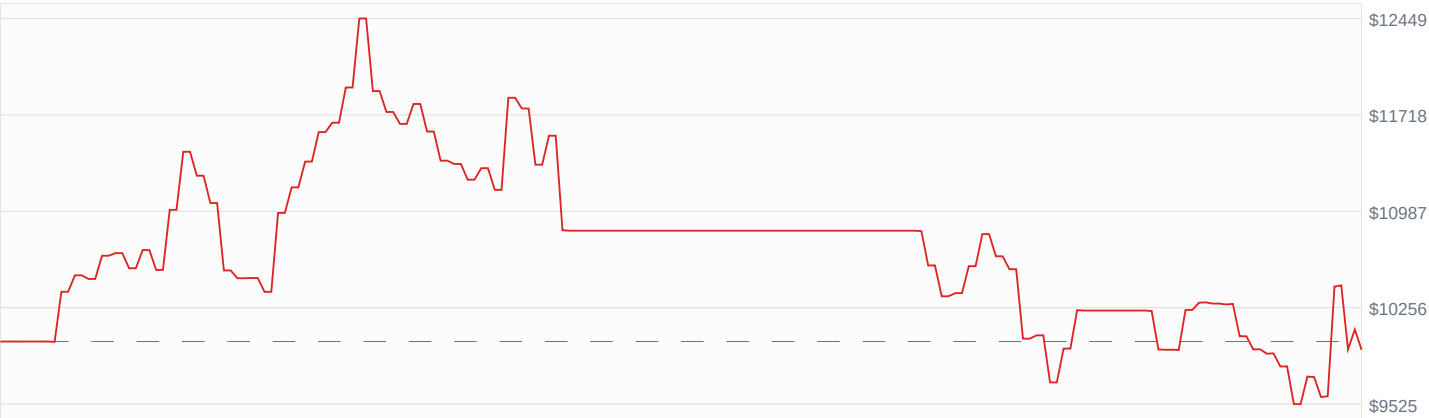

ANALYST NOTE

Hera local LLM

The EVO_GG1RSISNIP_v246 strategy on NVDA generated minimal losses with an ROI of -0.66%, yet the statistical confidence is critically low due to only 3 executed trades. A 33.3% win rate and 0.09 Sharpe ratio suggest the signal logic lacks edge, while the 23.49% drawdown indicates severe capital inefficiency per trade. This sample size is insufficient to validate the approach as a viable institutional alpha source. We must increase trade frequency through parameter tuning or adjust entry filters to generate a robust data set before deployment.
