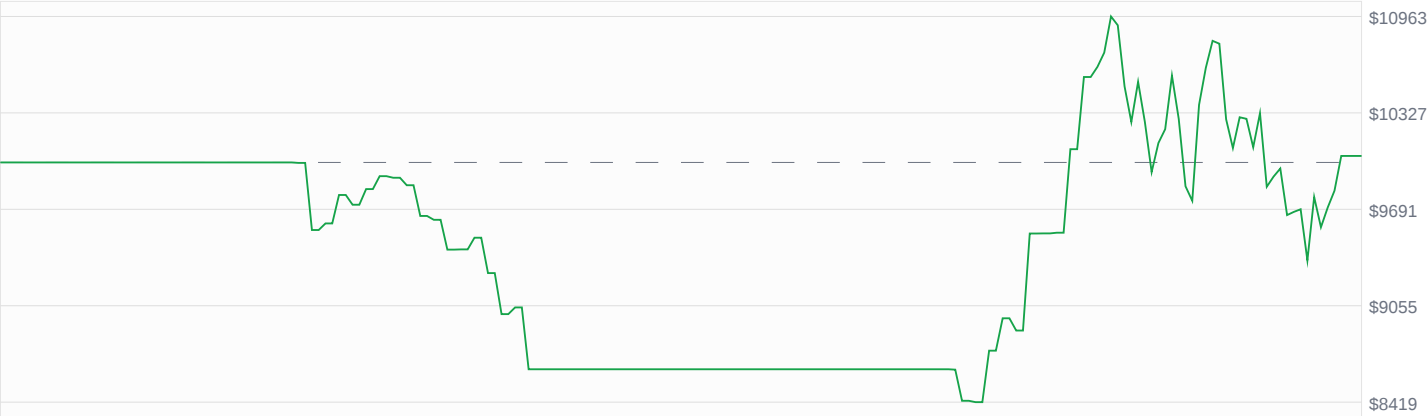

The EVO_EVOWEBIDEA_v415 strategy on PLMR generated a marginal +0.43% return but failed to establish statistical significance with only two trades executed. A low Sharpe ratio of 0.14 and a 14.67% maximum drawdown indicate excessive volatility relative to the minimal gains achieved. The fifty percent win rate suggests the current signal logic lacks a decisive edge in this specific market environment. To validate the approach, you must run a longer simulation on higher-frequency data to accumulate sufficient trade volume for robust performance metrics.
