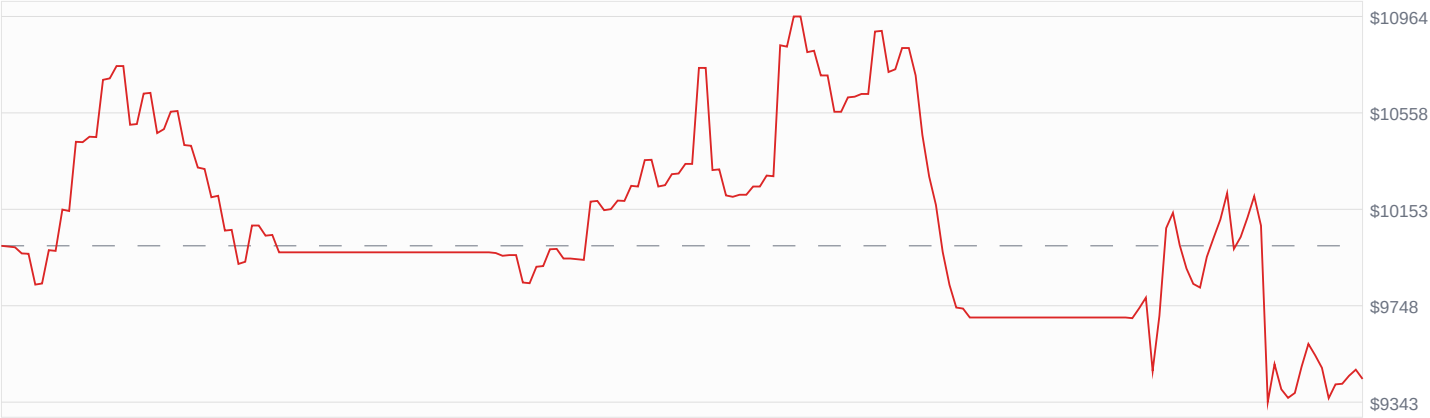

ANALYST NOTE

Hera local LLM

The EVO_GG1RSISNIP_v109 strategy on RDN failed catastrophically, losing over 5% capital with zero winning trades out of only three executed signals. A Sharpe ratio of -0.31 and a 14.78% maximum drawdown indicate severe risk exposure that is statistically meaningless given the tiny sample size. The bot essentially gambled on a single entry point rather than sustaining a systematic approach, leaving the final capital at \$9440.84. This result warrants immediate parameter tuning or a complete strategy overhaul before any further live deployment. The next step is to backtest on a longer timeframe to validate if the logic holds outside this specific volatility regime.
